NOTIFICATION

Whereas a public notice containing the draft of the Delhi Bharatiya Chikitsa Parishad (Amendment) Rules, 2013 to amend the Delhi Bharatiya Chikitsa Parishad Rules, 2000 was published, as required by section 37 of the Delhi Bharatiya Chikitsa Parishad Act, 1998 (Delhi Act No.4 of 1999), in the Delhi Gazette Extra Ordinary Part-IV having circulation in the National Capital Territory of Delhi on dated the 1st January, 2013 for inviting objections and suggestions from all persons likely to be affected thereby, within a period of thirty days from the date of publication of public notice;

And whereas no objection and suggestion was received from the public with respect to the said draft rules.

Now, therefore, in exercise of the powers conferred by sub-section (2) of section 37 of the Delhi Bharatiya Chikitsa Parishad Act, 1998 (Delhi Act No. 4 of 1999), the Lt. Governor of National Capital Territory of Delhi, hereby makes the following rules further to amend the Delhi Bharatiya Chikitsa Parishad Rules, 2000, namely:-

1. **Short title and commencement.**- (1) These rules may be called the Delhi Bharatiya Chikitsa Parishad (Amendment) Rules, 2013.
(2) They shall come into force on the date of their publication in the Delhi Gazette.
2. **Amendment of rule 10.**- For clause (d) of sub-rule (1) of rule 10 of the Delhi Bharatiya Chikitsa Parishad Rules, 2000, the following clause shall be substituted, namely:-

“(d) **Charging of Fees-**




